## EXHIBIT III STANDARDIZATION OF EXTERIOR PAINT AND COLORS FOR COUNTRY CLUB VILLAGE

The exterior walls of the house and the garage door will be painted the same color. Homeowners are limited to no more than two paint colors \*. If the walls and garage door are from Group B, the optional second color must be from Group A or C. If the walls and garage door are from Group A, then the second optional color must be from Group B or C. For example, if the walls and garage door are painted Camelback (Group B), then the trim, gutters, etc. must be painted Camelback, or one of the colors from Group A, or Baked Clay from Group C. Colors from Group C are not permitted for use as wall or garage door colors.
